

AHS ORCHESTRA'S SPRING 2012 TRIP

STUDENT TRAVEL CONTRACT

The student AND student's parents/guardians agree to the following:

1. The cost of the trip is \$1600.00 inclusive.
2. This signed contract and a **non-refundable deposit of \$250.00** must be returned (**signature pages only**), to the AHS Orchestra Director's office on or before September 15, 2011 in order to hold a reservation in the student's name.
3. The price of this tour is predicated on participation by a minimum of 175 people. Therefore, I the student understand that if for any reason I am not able to go on the tour as herein committed, I must notify the AHS Orchestra Booster Club Trip Committee in writing. I also understand that I may not be eligible for refund. This includes but is not limited to the possibility that I may become ineligible to go on the trip due to AISD regulations. That includes, but is not limited to academic eligibility.
4. If cancellation is made within 60 days of departure, no refund will be offered. At that point the only recourse is to offer the next person on the waiting list the opportunity to buy your trip. If there is no waiting list, the Orchestra Director will offer the trip to any current member of the Arlington High School Orchestra who is not restricted from attending. No other refunds will be expected or sought after from AISD, Arlington High School, the AHS Orchestra Department, AHS Orchestra Booster Club, and Orchestrated Travel.
5. Unused tickets will be disposed of in the most economic manner mitigating damages to the AISD, Arlington High School, the AHS Orchestra Department and the AHS Orchestra Booster Club.
6. In the event Arlington High School Orchestra's should cancel the tour, the student will receive a proportional refund of the reclaimed funds from the event providers.
7. If financial hardship is the only limitation to the student participating in this trip, the student may schedule an appointment with the Orchestra Director to discuss options.

8. All payments for the trip will be made on time and per the following schedule. If you are late with a payment and have not made appropriate arrangements with the AHS Orchestra Booster Club trip committee, your tour place may be forfeited to the first person on the waiting list. Payments must be received no later than the 30th of each month they are due.

9. It is the parent/guardian's responsibility to convey in writing or through direct conversation with the Orchestra Director any issue(s) with regard to, but not limited to, medication or behavior that would place the student, chaperon or other attendees in jeopardy.

Arlington High School Orchestra's Booster Club gives notice that all arrangements for transportation, conveyance, hotel accommodations and all tickets and coupons issued by them, are made by them as agents upon the express condition that they shall not be liable for student's injury, damage, loss, accident, delay or irregularities which may be occasioned either by reason of defect in vehicle, or through the acts of default of company or person engaged in conveying the passenger, or in carrying out the arrangements of the tour(s), or otherwise in connection therewith, or any hotel proprietor or servant.
2. Arlington High School Orchestra's Booster Club accepts no responsibility for losses or additional expenses due to delays or changes in bus, train, plane, or other services, sickness, weather, strikes, war, quarantine, or other causes, or act of God. Student and parents/guardians agree to release Arlington High School Orchestra's Booster Club, its agents and members from all claims arising out of such events, act or omissions.
3. Student and parents/guardians understand that Arlington High School Orchestra's Booster Club has offered these tours and itineraries based on fares and prices at the time of offering and grant Arlington High School Orchestra's Booster Club the right to change, add or withdraw any tour announced in this proposal and to make alterations in the itineraries and program costs as may be found necessary due to change in transportation costs, lack of participation or other cost differences. All offerings are subject to confirmation and/or an adjustment when payment for the tour is made. Student and parents/guardians understand that such changes in the program, including increases in program prices, are not grounds for withdrawal.
4. I understand that Arlington High School Orchestra's Booster Club will enforce the AISD Student Code of Conduct as outlined in the Student Handbook. Furthermore, Arlington High School Orchestra's Booster Club will require participants to adhere to any rules or standards that it establishes and communicates. Failure to comply with said standards and rules could mean immediate termination of student's participation in the program. Costs due to termination are at my own expense and unused portions of my program may not be refundable.
5. Student and parents/guardians understand that use of alcohol or tobacco products by minors or the use of illegal drugs or other violation of law is grounds for immediate rejection from the tour program.
6. Arlington High School Orchestra's Booster Club is not responsible for student's well-being while not with the group.
7. Any statements made by participants or photographs taken of participants while on tour may be used by the AISD, Arlington High School, the AHS Orchestra Department, and the AHS Orchestra Booster Club in any future publicity materials or promotional publications.
8. Student and parents/guardians understand that the AISD, Arlington High School, the AHS Orchestra Department, and the AHS Orchestra Booster Club, its agents and employees are not responsible for any financial liability or obligation which I may incur, or injury or damage to the person or property of others which I may cause or contribute to while on this tour.
